



CURRENT GUIDELINES FOR USE OF SC-TV

The purpose of SC-TV is to inform Spruce Creek Fly-In Owners and Residents about upcoming meetings and events within the Community. It is for use by SCPOA Owners', Residents and Commercial Businesses located in Spruce Creek Fly-In. If you have a Bright House digital box on your TV, you will get SC-TV on **Channel 701**. You have to enter 701 on your remote. It cannot be accessed with your up and down button. If you do not have a digital box, SC-TV can be accessed on **Channel 2**.

Ads must be submitted on the 8 ½" X 11" form (available at the SCPOA Office or online at www.scpoa.com), completed and delivered or faxed to the Office with your name, address and phone number included. If a photo is to be included in your ad, submit just one photo to the POA Office on a CD/DVD in .JPG FORMAT ONLY. If you want it for use at another time, pick it up as soon as your ad appears. We do not save your CD/DVD. Please do not submit a Power Point Slide, Word Document or floppy disk. They cannot be used. Your ad may be edited due to limited space and based on availability of blank slide space. All ads are subject to rejection if deemed inappropriate or do not comply with these Guidelines.

IF IT ISN'T IN THE FLY-IN, IT ISN'T ON SC-TV

1. **POA NOTICES**: Notices of Board Meetings, Committee Meetings and other SCPOA announcements as needed.
2. **COMMUNITY EVENTS**: Announcements showing date and time for non-profit SCPOA sanctioned Community events to be held in Spruce Creek Fly-In are permitted for up to four (4) weeks in advance of the event.
3. **CLASSIFIED ADS**:
 - a. Everything advertised on SCTV must be owned by the resident advertising. 2 slides per family per 2 week period are permitted and then off for 2 weeks before being back on for another 2 weeks.
 - b. Residents who advertise commercial services from home (e.g. lawn & yard care, power washing, car washing or detailing) are limited to 1 slide per quarter (4 times per year) to run for 2 weeks. Customer traffic or delivery vehicles not allowed at the home.
 - c. Personal in-home service ads (e.g. babysitting, pet care, house cleaning, health or beauty care) are permitted for up to 2 weeks, then off for 2 weeks before being allowed back on for another 2 weeks.
 - d. Real Estate being advertised for sale or rent in Spruce Creek Fly-In must not have been listed with a realtor, real estate agent or a property manager and may only be advertised by the owner of the property.
 - e. Sale of firearms is not permitted.
 - f. Political notices/advertisements not permitted.
4. **PERSONAL NOTICES**:
 - a. An announcement pertaining to death, memorial service or thank you to the community is permitted for 7 days.
 - b. Solicitations for a Charity are allowed if a resident is collecting items or funds directly to their home in Spruce Creek Fly In and the resident's personal information is listed (such as telephone number and address), not the charity's. Permitted for up to 2 weeks.
 - c. Solicitations for charities or special events outside of Spruce Creek Fly-In are not permitted.
5. **COMMERCIAL ADS**: A properly zoned and licensed business located in Spruce Creek Fly-In is limited to 1 slide per quarter (4 times per year) for up to 2 weeks. All Property, Services or Events located outside Spruce Creek Fly-In or ads for businesses located outside Spruce Creek are not permitted.
6. **SPRUCE CREEK COUNTRY CLUB**: Notices permitted for up to four (4) weeks before events, (based on availability of blank slide space)
7. **AIRPLANES/AVIATION ADS**: Permitted for up to 2 weeks, then off 2 weeks before being permitted back on for another 2 weeks.
8. **LOST & FOUND NOTICES**: Permitted for up to 2 weeks.
