



## CURRENT GUIDELINES FOR USE OF SC-TV (formerly Channel 2)

The purpose of SC-TV is to inform owners & residents about upcoming meetings & events within the Community. It is for use by Spruce Creek Property Owners Association Residents & Commercial Businesses located in Spruce Creek Fly-In. If you have a digital box on your TV, you will get "SC-TV" on Channel 701. You have to enter 701 on your remote. It cannot be accessed with your up & down button. If you do not have a digital box, "SC-TV" can be accessed on Channel 2 as usual.

Ads must be submitted on the provided 8 ½" X 11" form & delivered or faxed to the SCPOA Office with your name, address & phone number included. If a photo is to be included in your ad, it must be submitted to the POA Office on a floppy or CD in .JPG FORMAT. We do not save your floppy or CD after your ad appears. Pick it up when you see that your ad is posted, if you will need it again. Please do not submit a Power Point Slide or a Word Document. They cannot be used.

**ALL ADS ARE SUBJECT TO REJECTION IF DEEMED INAPPROPRIATE. YOUR AD MAY BE EDITED DUE TO LIMITED SPACE AND BASED ON AVAILABILITY OF BLANK SLIDE SPACE.**

Volunteers have been trained and are the only persons permitted to use the SC-TV computer.

1. **POA NOTICES:** Notices of Board Meetings, Committee Meetings and other SCPOA announcements as needed.
2. **COMMUNITY EVENTS:** Announcements showing date and time for non-profit SCPOA sanctioned Community events to be held in Spruce Creek Fly-In. Permitted for up to 4 weeks in advance of event.
3. **CLASSIFIED ADS:**
  - a. **ITEMS ADVERTISED ON SC-TV MUST BE OWNED BY THE RESIDENT ADVERTISING.** Two slides per family per two-week period are permitted, then off 2 weeks before being permitted back on for another 2 weeks.
  - b. Residents who advertise product lines from home or advertise business from home are limited to 1 slide per quarter (4 times per year).
  - c. **Real Estate being advertised for sale or rent MUST BE OWNED BY FLY IN RESIDENT AND MUST NOT HAVE BEEN LISTED WITH A REALTOR OR REAL ESTATE AGENT.**
  - d. **SALE OF FIREARMS IS NOT PERMITTED.**
4. **PERSONAL SERVICE ADS:**

**Non-commercial** personal and home services are allowed. i.e. babysitting, pet care, home, health or beauty care. Permitted for up to 2 weeks, then off 2 weeks before being allowed back on for another 2 weeks.
5. **PERSONAL NOTICES:**
  - a. Announcement pertaining to death, memorial service or thank you to the community are permitted for 7 days.
  - b. Solicitations for a charity are allowed if a resident is collecting items or funds directly to their home in Spruce Creek Fly In & the resident's personal information is listed (such as telephone # and address), not the charity's. Permitted for 2 weeks.
  - c. Solicitations for charities or special events outside of Spruce Creek Fly-In are not permitted.
6. **COMMERCIAL ADS:** A properly zoned & licensed business located in Spruce Creek Fly-In is limited to one (1) slide per quarter (4 times per year) for up to 2 weeks. Ads for items or services located outside Spruce Creek or ads for businesses located outside Spruce Creek are not permitted.
7. **SPRUCE CREEK COUNTRY CLUB:** Notices permitted for up to 4 weeks before events (based on availability of blank slide space)
8. **AIRPLANES/AVIATION ADS:** Permitted for up to 2 weeks, then off 2 weeks before being permitted back on for another 2 weeks.
9. **LOST & FOUND NOTICES:** Permitted for up to 2 weeks.
